

**ORDINANCE NO.2023-11**

**OF THE CITY OF PERU, NEMAHA COUNTY, NEBRASKA**

**AN ORDINANCE AUTHORIZING SUSPENSION OF RULES FIXING COMPENSATION OF THE OFFICERS AND EMPLOYEES OF THE CITY OF PERU; TO PROVIDE FOR THE REPEAL OF ALL PRIOR ORDINANCES IN CONFLICT HEREWITH; ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM; AND TO PROVIDE THE EFFECTIVE DATE HEREOF.**

**BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PERU, NEBRASKA;**

SECTION 1. The City Council by three-fourths (3/4<sup>th</sup>) vote of the majority or greater hereby suspends the rules to allow this Ordinance to be read aloud and moved for final passage at the same meeting.

SECTION 2. City Council. The compensation of members of the City Council shall, in addition to necessary expenditures such as meals, millage, and lodging as may from time to time be fixed by the Budget or other Resolution of the City Council, in compliance and accordance with Neb. Rev. Stat. 13-2203, be and the same hereby is, fixed at the sum of \$300.00 per Quarter for each of the members of the City Council.

SECTION 3. Mayor. The compensation of the Mayor shall, in addition to necessary expenditures, such as meals, millage, and lodging, as may from time to time be fixed by the Budget or other Resolution of the City Council, in compliance and accordance with Neb. Rev. Stat. 13-2203, be and the same hereby is, fixed at the sum of \$375.00 per Quarter.

SECTION 4. Officers and Employees of the City. The officers and employees of the City, hereafter named shall, in addition to necessary expenditures such as meals, millage, and lodging, as may from time to time be fixed by the Budget or other Resolution of the City Council, in compliance and accordance with Neb. Rev. Stat. 13-2203, be the same hereby is fixed in accordance with the following respective wage rages, and in accordance with such rules as the City Council may by resolution establish:
