ORDINANCE NO.2023-06

OF THE CITY OF PERU, NEMAHA COUNTY, NEBRASKA

AN ORDINANCE AUTHORIZING SUSPENSION OF RULES FIXING COMPENSATION OF THE OFFICERS AND EMPLOYEES OF THE CITY; TO REPEAL CONFLICTING ORDINANCES AND SECTIONS OF SAID CITY; AND PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PERU, NEBRASKA;

SECTION 1. The City Council by three-fourths (3/4th) vote of the majority or greater hereby suspends the rules to allow this Ordinance to be read aloud and moved for final passage at the same meeting.

SECTION 2. That the Compensation and other benefits of the officers and employees of the City of Peru, Nemaha County, Nebraska, is hereby fixed by category as follows:
